Miss Ivy's Gazebos at Mount Edgcumbe: We are able to offer 3m x 3m pitches at £40.00 4.5 m x 3m pitches at £50.00 & 6m x 6m at £65.00 all at the front of the house and in the Barrow Centre. Gazebos will be provided and erected for all stallholders. Please note that due to the large size of the 6m x 3m gazebos there will be 2 businesses in each gazebo if a 3m x 3m pitch is booked. If you wish to share with a particular business please let us know.

Our aim is to have as broad a selection of quality products relevant to each Market as possible on sale to satisfy both customers and stallholders. Please note that due to the popularity of the event for stallholders, **the completion and return of this application form and deposit payment is not confirmation of your pitch booking.**

- 15th April 2017 – Application Form, copy of Public Liability Insurance Certificate, Risk assessment and full payment to be received by Miss Ivy Events Ltd.
- 22nd April 2017 - Stall holder to receive confirmation of booking and (if applicable) cheque to be cashed. Unsuccessful applications to be notified and deposit payment to be refunded. (Cheque returned or BACS refund to be made). OR within 7 days of booking form being received.
- Once your booking has been confirmed, failure to commit to the date booked will result in the loss of your stall fee.

Insurance & Risk Assessment

Mount Edgcumbe 2017 Markets

- Stallholders are responsible for their own Public Liability Insurance up to 5 million. The organisers accept no liability for damage or loss of goods or equipment nor any liability for injury to persons at the event. If stall holders are selling food or drink items, a copy of your food and hygiene certificate must be sent with your application.
- All stallholders must complete a risk assessment if we do not already hold one on file.
- The Show Organiser and the land owner will try and ensure the event takes place. However, if conditions are deemed severe enough to create a risk to health & safety, the event will be cancelled. A decision to cancel, may be as near as the day prior, on the day or during the event.
- In the event of cancellation, the organisers will not be held responsible for any loss to the stallholders (including financial loss). In the advent of extreme weather conditions, stallholders can check if the event is going ahead by calling The Show Organiser on the number provided at time of booking and checking social media. In the event of cancellation the day prior to the event a text and/or email will be sent.

Stall information

- Please do not place any items in front of your gazebos or outside of the space you have booked as this is a Health and Safety risk. You will be asked to remove any items that could cause an obstruction.
- There is no access to electric on site.
- **Tables and chairs are not provided - there is an option to order table and chairs on the application form above.**
- All gazebos must be treated with respect - any damage incurred while you are trading you will be liable for and will be invoiced accordingly.
- The hire of the gazebo includes industrial strong weights.
- Car parking will be available on site for exhibitors.
