#### **Gin & Rum Festival**

- Application Form, copy of Public Liability Insurance Certificate, Risk assessment and full payment to be received by Miss Ivy Events Ltd.
- Within 7 days stall holder to receive confirmation of booking. Unsuccessful applications to be notified and deposit payment to be refunded. ( BACS refund to be made).
- Once your booking has been confirmed, failure to commit to the date booked will result in the loss of your stall fee.

#### **Payments**

- Please ensure that you quote reference APRIL13TH when paying by BACS.
- BACS payment should be made to Miss Ivy Events Ltd, Sort code 30-98-46, Account number 23492468.

#### **Insurance & Risk Assessment**

- Stallholders are responsible for their own Public Liability Insurance up to 5 million. The organisers accept no liability for damage or loss of goods or equipment nor any liability for injury to persons at the event. If stall holders are selling food or drink items, a copy of your food and hygiene certificate must be sent with your application.
- All stallholders must complete a risk assessment if we do not already hold one on file.
- If selling alcohol you must provide a copy of your personal licence for us to keep on record
- The Show Organiser and the land owner will try and ensure the event takes place. However, if conditions are deemed severe enough to create a risk to health & safety, the event will be cancelled. A decision to cancel, may be as near as the day prior, on the day or during the event.
- In the event of cancellation, the organisers will not be held responsible for any loss to the stallholders (including financial loss) a credit will be given against another event for any pitch fees. In the advent of extreme weather conditions, stallholders can check if the event is going ahead by calling The Show Organiser on the number provided at time of booking and checking social media. In the event of cancellation the day prior to the event a text and/or email will be sent.

**Stall information**

- Please do not place any items in front of the space you have booked as this is a Health and Safety risk. You will be asked to remove any items that could cause an obstruction.
- There is access to electric on site all electrical equipment must be PAT tested and a certificate sent prior to the event.
- Stall fee includes 2 exhibitor passes only. These will be given to you on arrival on the day
